3. The Photo Contest Chairman reserves the right to determine how to display entries. Removal of entries from the Photo Contest or Art Show Room without prior approval of the Photo Contest Chairman and presentation of the claim check is prohibited.
4. All entries must have a declared value. (Value should be based on the cost to replace the photo or slide, not duplicate the shot.)
5. After filling out this Entry Form and the Judge's Score Sheet, if applicable, return both to the Photo Contest Staff who will provide an Entry number which they will place on the Entry Form and on the photo or slide, Judges Scoring Sheet, Claim Check and Entry Identification Tag. Place entry with Identification Tag attached in the designated location. Retain the Claim Check, which must be presented to pick up the entry at the end of the contest. Additional identification may be required at time of pickup.
6. I hereby certify that this entry is entirely my/our own work or that I made the original exposure. I also hereby release the NMRA and the Northeastern Region and all persons connected with this Contest from any liability due to damage to or loss of the entry greater than that covered by the NMRA insurance coverage.
